**CIRCULAR**

**Sub: - Blacklisting of Firm- M/s Nitash Co-generation Private Limited (CIN No. U40100MH1999PTC118230) having its registered office at 218, Wadala Udyog Bhawan, Naigaun Cross Road, Wadala, Mumbai- 400 031 and its Directors (i) Shri. Manohar P. Moholker-DIN: 01553939 (ii) Mrs. Mrinali Manohar Moholker-DIN: 01494752 (iii) Shri Keshav Janardan Ajsaonkar-DIN: 00106731 (iv) Mrs. Radhika Mukund Nadkarni-DIN: 01460725.**

M/s Nitash Cogeneration Private Limited (M/s. Nitash) had signed Power Purchase Agreement (PPA) dated 7.06.2007 with Gujarat Urja Vikas Nigam Limited (GUVNL) for supply of 60.2 MW power from their Bagasse based cogeneration power project to be located at Narmada Khand Udhyog Sahkari Mandali Limited, Dist. Narmada. As per the PPA, the Scheduled Commercial Operation Date (SCOD) of the project was 48 months from the signing of PPA i.e. by 6.06.2011.

As per Clause 4.3 of the PPA dated 7.06.2007, it was agreed between the parties that, in the event of delay in commissioning of the project beyond the SCOD, M/s. Nitash shall pay GUVNL, liquidated damages for delay at the rate of Rs. 3000 per day per MW for a maximum period of 365 days after which GUVNL may terminate the PPA.

Since, M/s. Nitash failed to pay the amount of liquidated damages, GUVNL had filed a Petition No 1202 of 2012 before Gujarat Electricity Regulatory Commission (GERC) for recovery of liquidated damages of Rs. 6.59 Crores from M/s. Nitash for delay /non commissioning of Bagasse based Co-generation project.

GERC through order dated 6.11.2012 decided the above petition directing that the liquidated damages of Rs. 6.59 Crores be paid by M/s. Nitash to GUVNL within the period of 14 months as a principal amount of liquidated damages payable as per the terms and conditions of PPA dated 6.06.2007.

M/s. Nitash did not comply with the GERC order dated 6.11.2012 and failed to make any payment towards LD even after expiry of 14 months from GERC order dated 6.11.2012. Therefore, GUVNL had filed an Execution Petition being
