OBC Bank was further pursued by this office for confirmation of issuance of BG vide this office letter no vide no.03-04/T-45-FPS/720 dated 20.08.2019.

In response to the above AGM, OBC bank circle office Delhi (South East) Harsha Bhawan, E-Block, Connaught place, New Delhi-110001, clarified vide their letter no CO/DSE/BG CON/2904 Dated 26.08.2019 that Captioned Bank Guarantee has not been issued by their branch. Later on AGM, MSME Credit, Corporate office Gurgram, having Office at plot No 5, Sect-32, Institutional area Gurgaon-122001 vide letter No. HO/MSME/569/2019-20 dated 04/09/2019 clarified that BG No-ORBC1750BGFD000679 is a **fake BG** and it has not been issued by their Branch".

On basis of confirmation of said BG by issuing bank as above, a Notice was issued to you vide this office letter 03-04/18-19/T-45/FPS/722 dated 06.09.2019 to submit reply on the matter.
